## DuPage County Weekly Respiratory Illness Surveillance Report<sup>1</sup> Week 42: 10/15/2023 – 10/21/2023

*This report summarizes key respiratory illness surveillance indicators in DuPage County. Indicators include reportable conditions (influenza intensive care unit admissions, pediatric influenza deaths, novel influenza A viruses), emergency department syndromic ([ILI](#), [CLII](#), [RSV](#), and [BARI](#)) and outpatient sentinel (ILI) surveillance trends, long-term care facility outbreaks, school absenteeism data, medication sales, and hospital capacity data.<sup>1</sup> All data are provisional and may change as additional reports are received. ### Summary for Week 42

- Based on surveillance system indicators, **influenza-like illness**<sup>2</sup> activity in DuPage County is currently estimated to be **low**.
- DuPage County's [COVID-19 Hospitalization Admission Level](#) is **low**.
- **No influenza-associated intensive care unit (ICU) admissions** were reported (2023-2024 influenza season provisional total: 0 cases).
- **No influenza-associated pediatric deaths** were reported (2023-2024 influenza season provisional total: 0 deaths).
- **No influenza A, novel virus cases** were reported.
- **2 respiratory illness outbreaks** were reported in long-term care facilities (LTCF). 2023-2024 season provisional total = 10 outbreaks:
  - COVID-19: 10
  - Influenza or influenza-like illness: 0
  - RSV: 0
- **No clusters of increased ILI absenteeism** were reported in schools (2023-2024 influenza season provisional total: 0 clusters).
- **There were increases in over-the-counter medication sales** for ILI-related conditions this week.
- **No hospitals were on bypass** this week due to insufficient capacity.

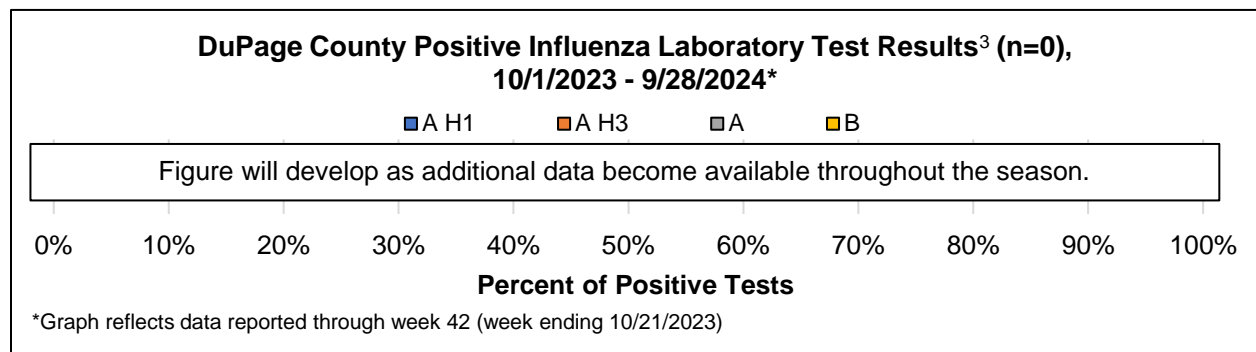
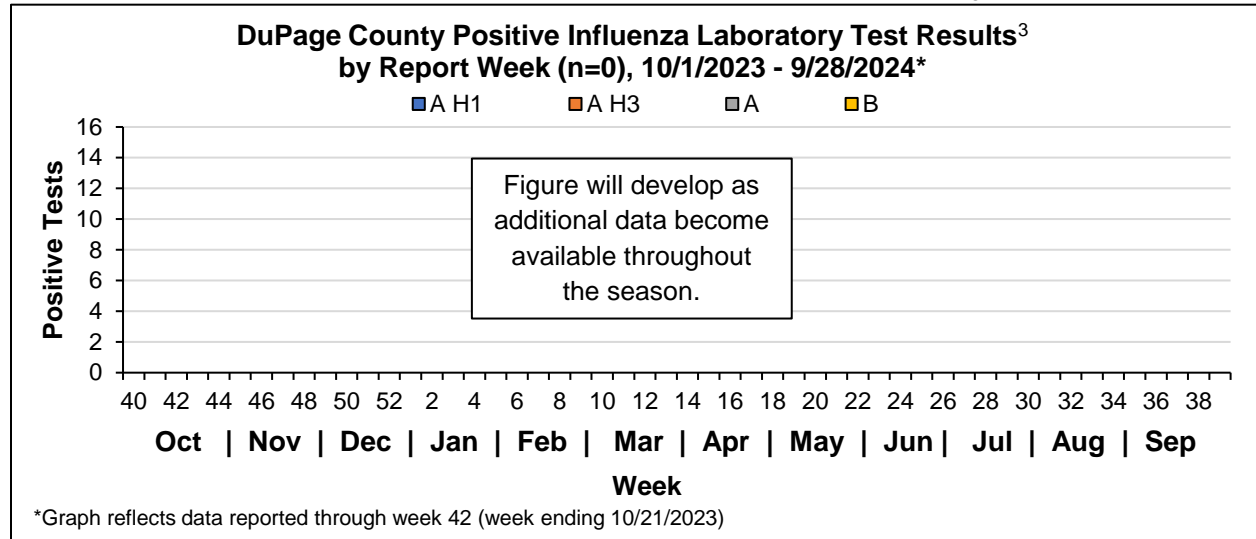
**Influenza Intensive Care Unit Hospitalizations**

Influenza intensive care unit (ICU) hospitalizations are reportable in Illinois per the [Control of Communicable Diseases Code](#). Deaths include ICU hospitalized cases where the death is due, in full or in part, to influenza.



**Influenza Laboratory Test Results**

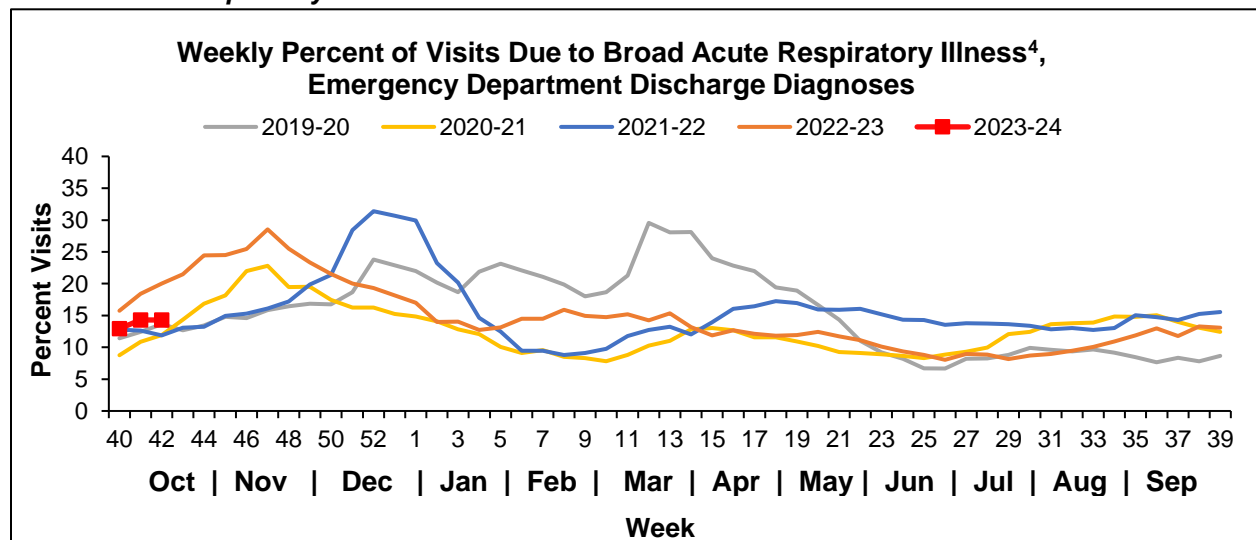

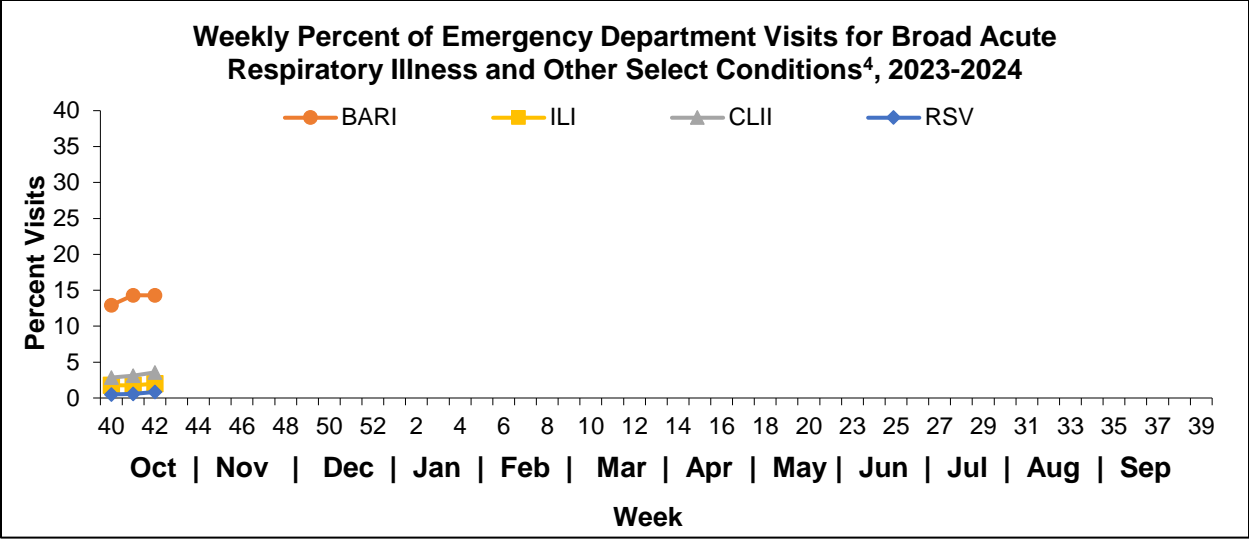


**Emergency Department Respiratory Illness Activity<sup>4</sup>**

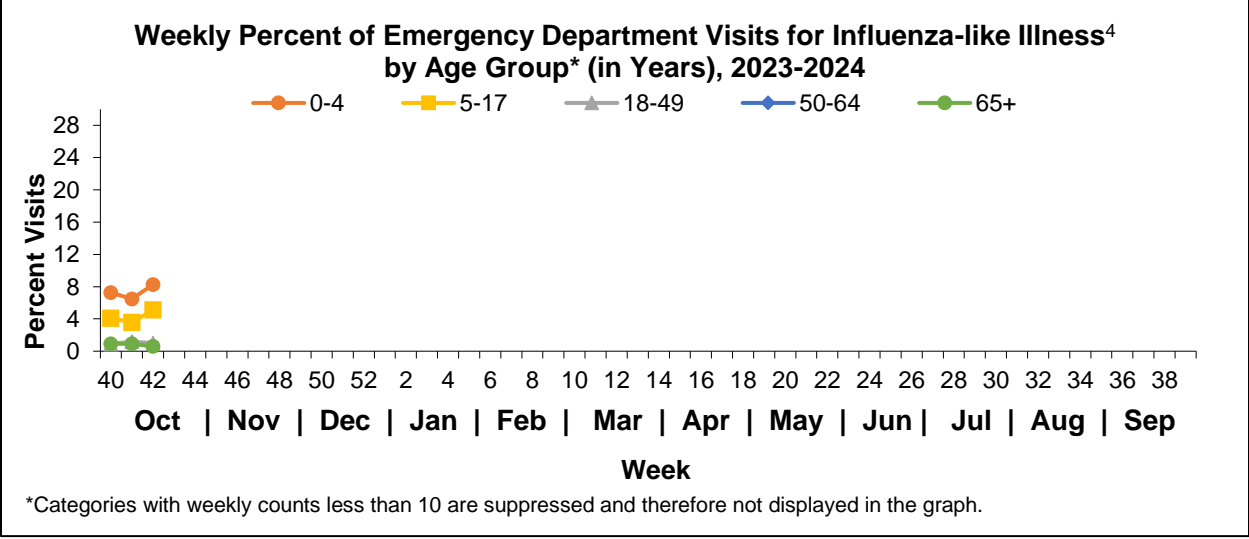
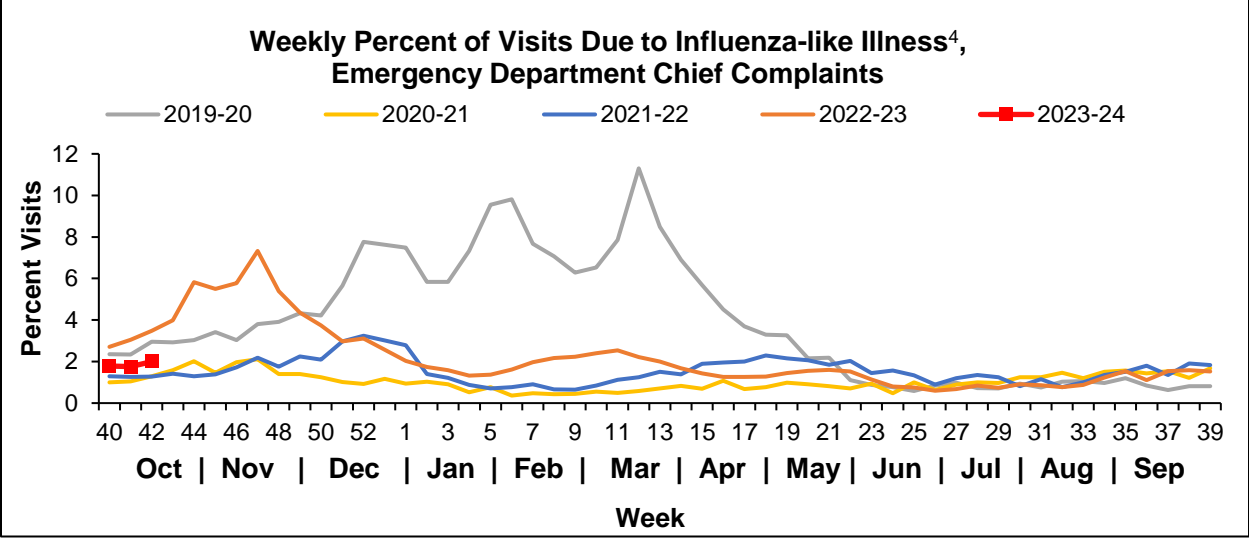
Hospital Emergency Department (ED) [syndromic surveillance](#) data, including chief complaints and discharge diagnoses, are reported in near real-time to the Illinois Department of Public Health (IDPH) through Electronic Surveillance System for the Early Notification of Community-based Epidemics (ESSENCE). Data below include ED visits at all six DuPage County acute care hospitals for broad acute respiratory illness (BARI), influenza-like illness (ILI), COVID-19-like illness and/or infection (CLII), and respiratory syncytial virus (RSV).

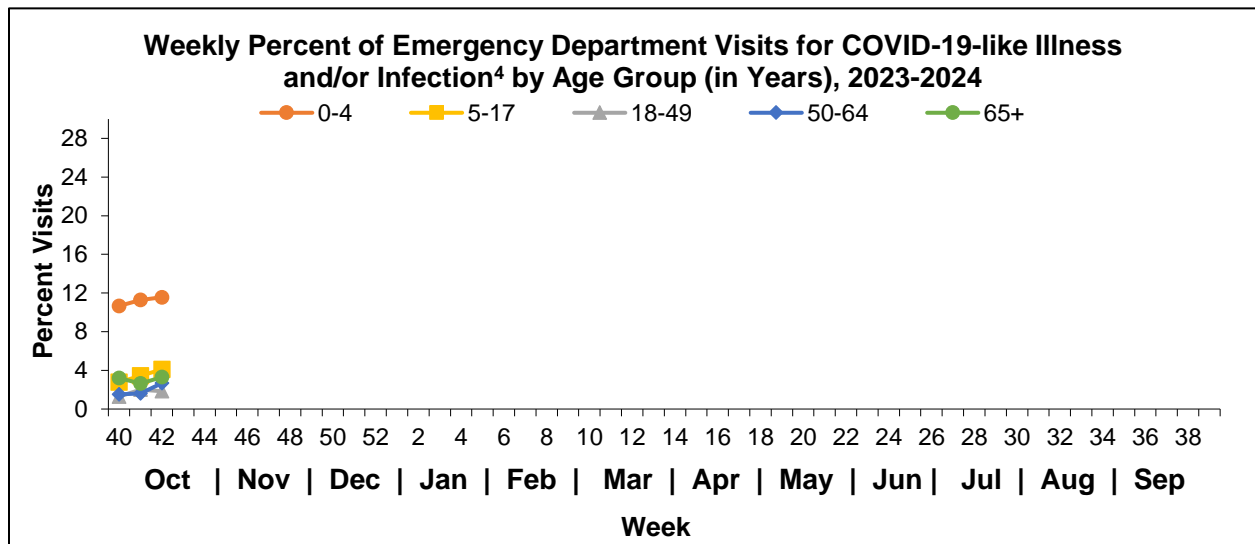
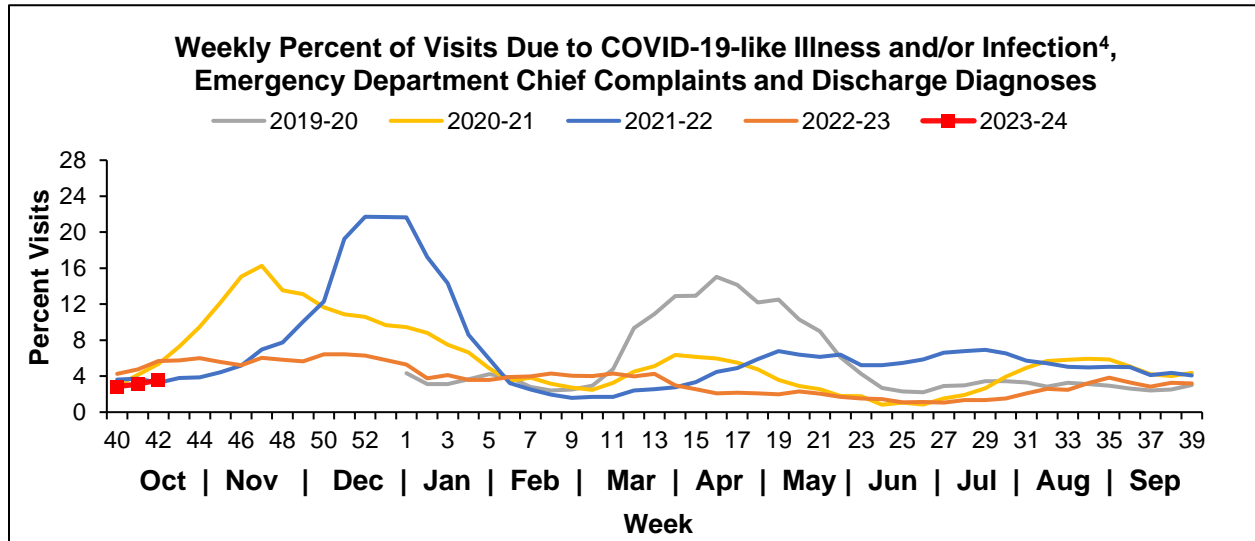




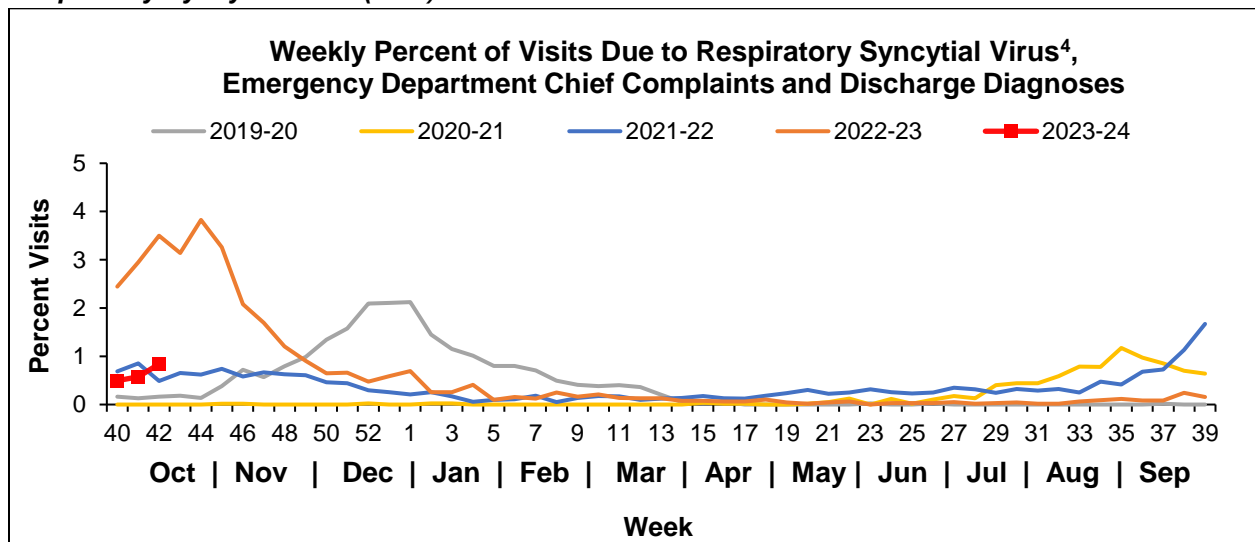
**Influenza-like Illness**

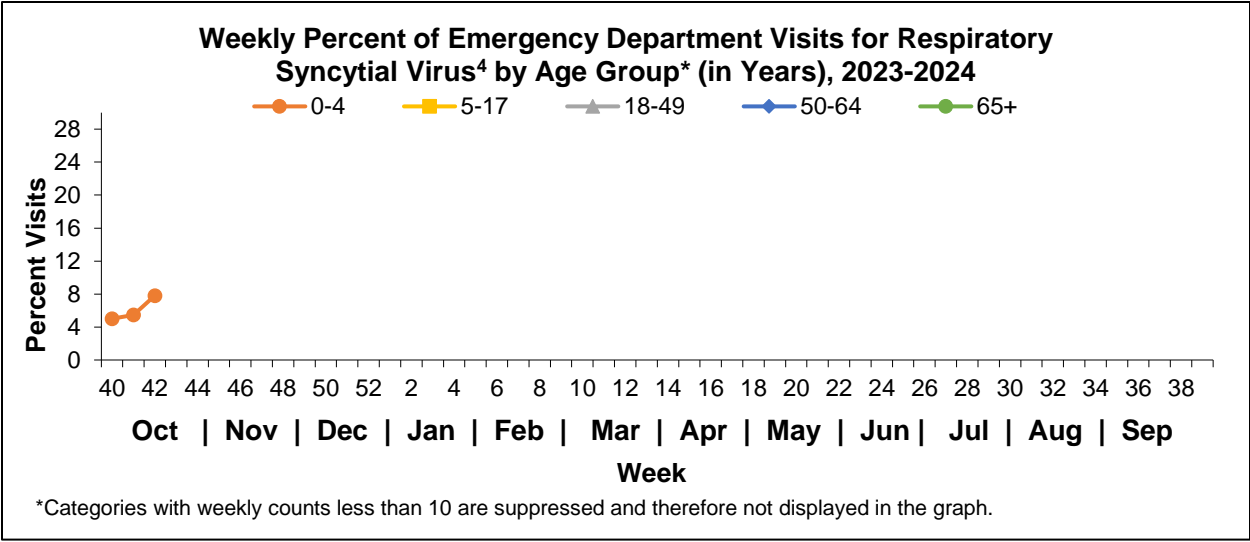


**COVID-19-like Illness and/or Infection**

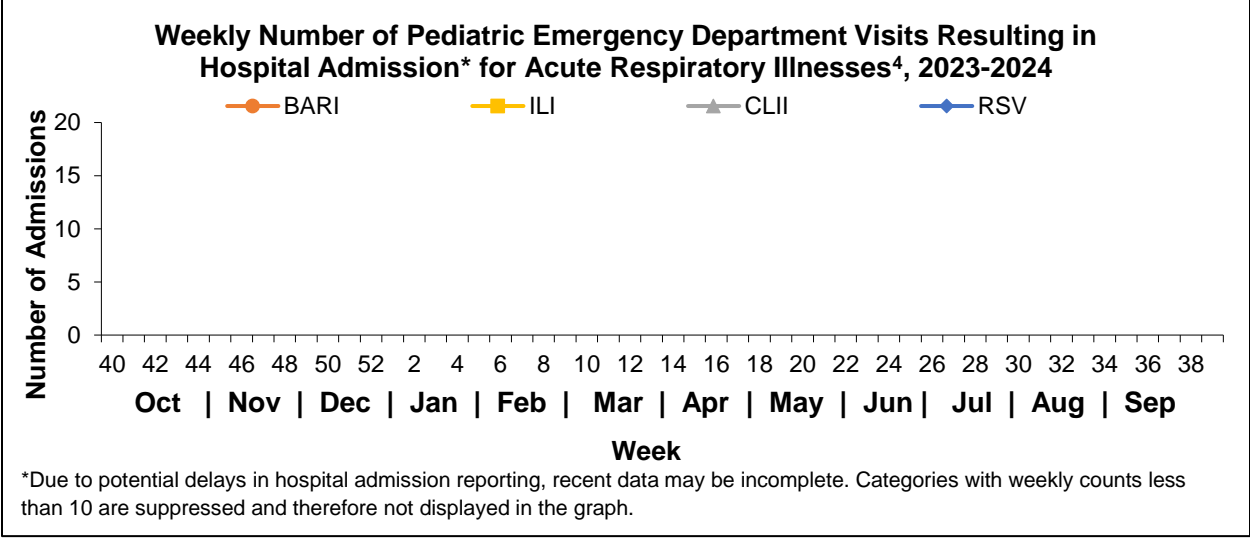
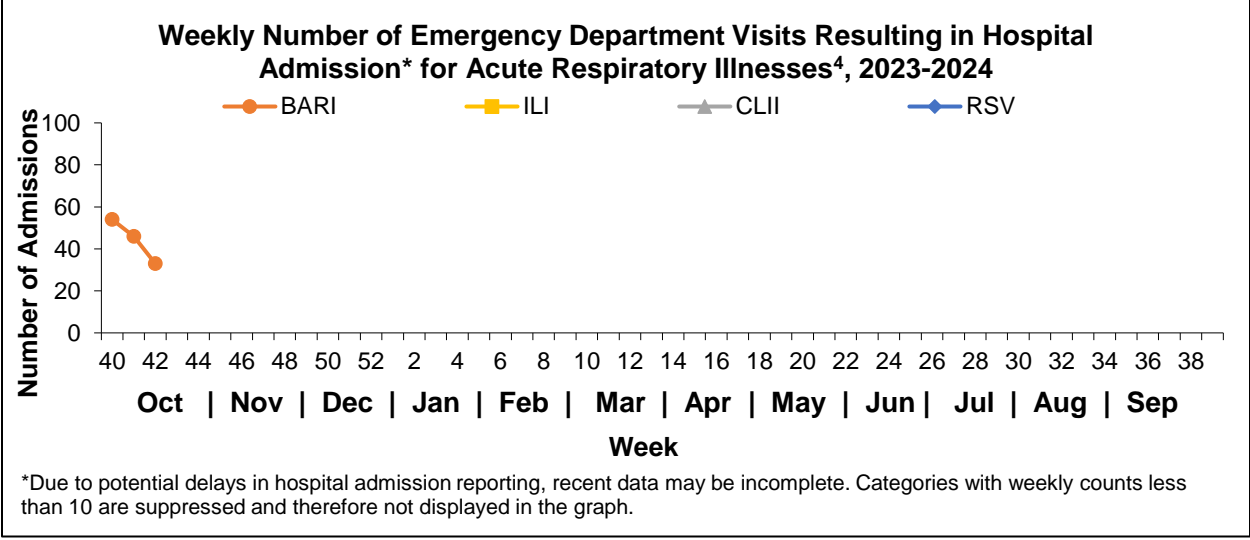


**Respiratory Syncytial Virus (RSV)**



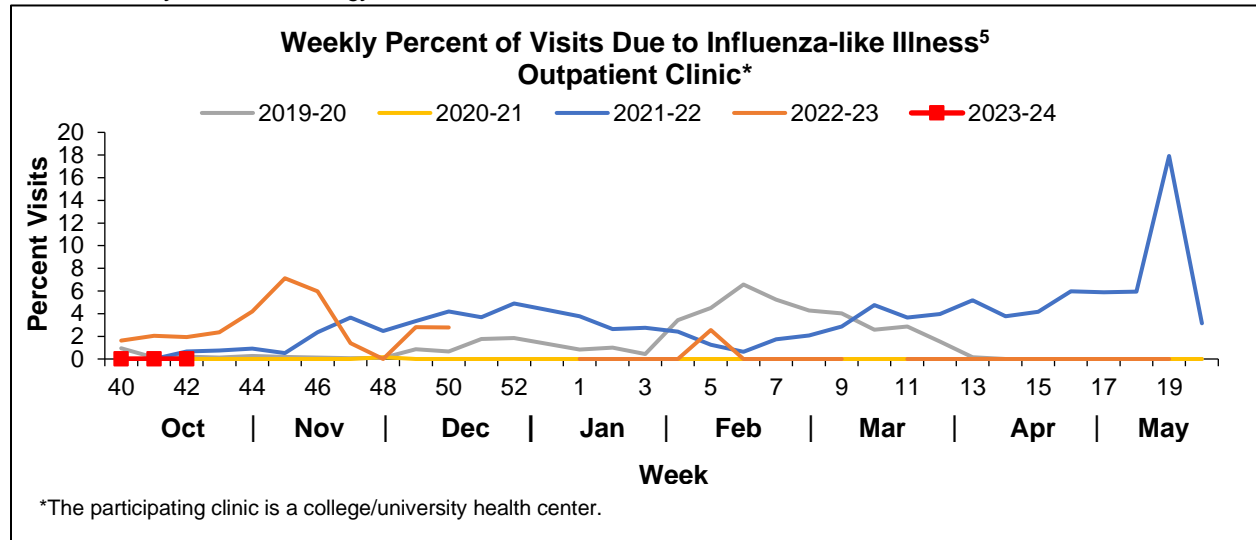


**Emergency Department Visits Resulting in Hospital Admissions**



### Outpatient Clinic Influenza-like Illness Activity

For the 2023-2024 season, one outpatient clinic (a college/university student health center) in DuPage County reports the number of visits for ILI using the Centers for Disease Control and Prevention's (CDC) Influenza Sentinel Provider Surveillance System methodology.



### School Absenteeism

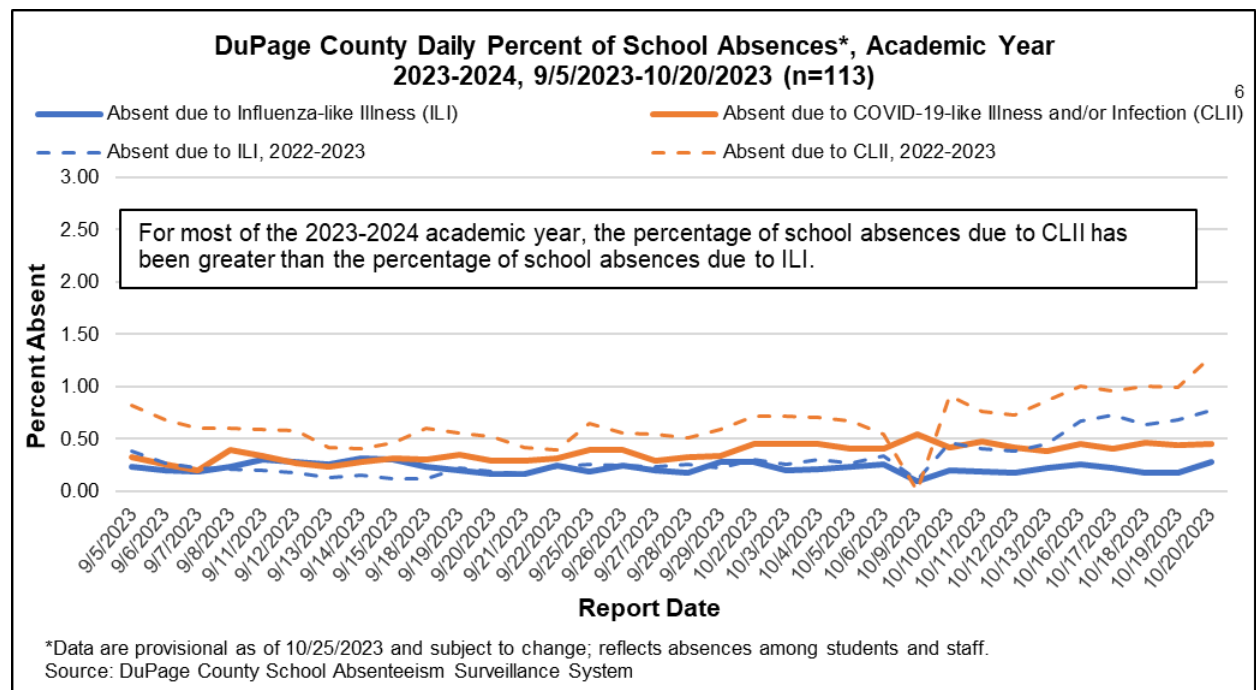
School absenteeism surveillance helps alert school administration and the community to times of increased risk and take the necessary precautions to interrupt the spread of disease. School absenteeism is tracked for DuPage County public and private schools through a voluntary, secure, online reporting platform. Data are collected on absences due to influenza-like illness (ILI), COVID-19-like illness and/or infection (CLII), other (non-illness), unknown reasons, in-school presentation of illness, and total illness among students and staff.

DuPage County Health Department received absenteeism reports from **97 schools (24.7% of 392 public and private schools)** with in-person attendance by students or staff during **Week 42**.

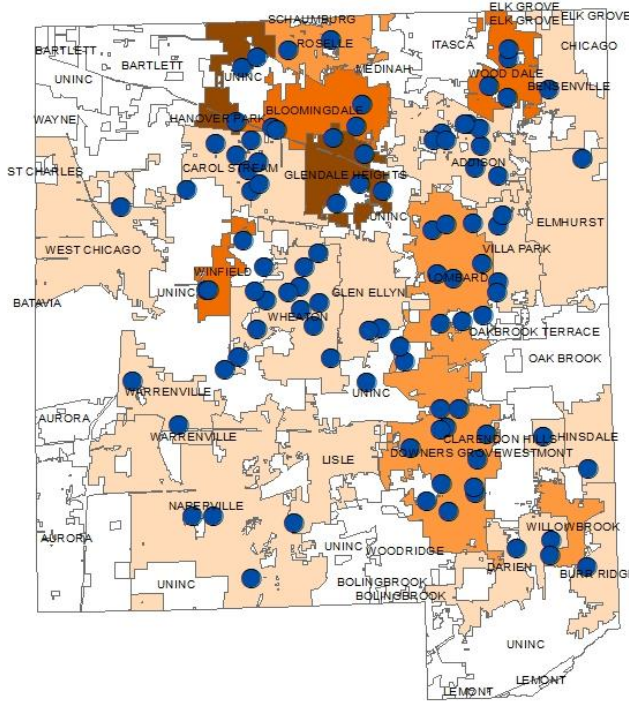
For **Week 42**, the overall **school absenteeism rate** due to:

- **ILI was 2.22 per 1,000 students and staff**
- **CLII was 4.42 per 1,000 students and staff**

**No clusters** of increased ILI absenteeism were reported in schools.

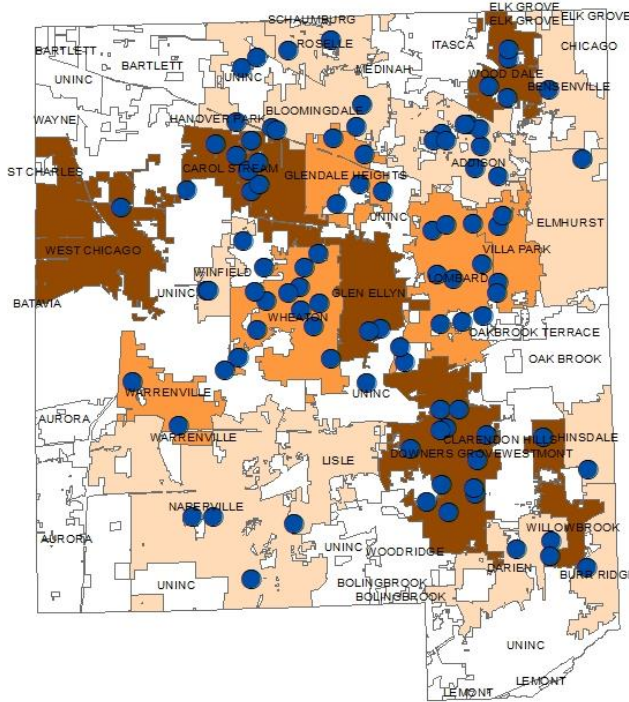

<sup>1</sup> DuPage County Health Department (DCHD) tracks respiratory illness surveillance indicators through a variety of methods. Indicators and sources include: 1) reportable conditions such as influenza intensive-associated care unit admissions, pediatric influenza deaths, and novel influenza A virus cases (source: Illinois-Electronic Disease Surveillance System), 2) long-term care facility outbreaks (source: Outbreak Reporting System), 3) emergency department visits categorized by chief complaint and/or discharge diagnosis (source: Early Notification of Community-based Epidemics [ESSENCE]), 4) outpatient sentinel surveillance (source: Centers for Disease Control and Prevention [CDC] Influenza Sentinel Provider Surveillance), 5) school absenteeism (source: DuPage County school absenteeism system portal), 6) over-the-counter medication sales (source: Real-time Outbreak and Disease Surveillance [RODS]), 7) hospital capacity data (source: EMResource). All data are preliminary and may change as additional reports are received. DuPage County population data are available [here](#).

<sup>2</sup> ILI activity defined as: low – minimal or no ILI activity, moderate – increased ILI activity, high – elevated ILI activity.

<sup>3</sup> Laboratory data include results received for reportable cases and outbreaks, including influenza-associated intensive care unit admissions, pediatric influenza deaths, novel influenza A virus cases, and influenza outbreaks at long-term care facilities.

<sup>4</sup> ESSENCE emergency department data compiled using the following queries available within ESSENCE : broad acute respiratory illness (BARI) defined using the CDC Broad Acute Respiratory DD v1 query, influenza-like illness (ILI) defined using the ED chief complaint ILI syndrome definition set by the National Syndromic Surveillance Program, COVID-19-like illness and/or infection (CLII) defined using the CLI CC with CLI DD and Coronavirus DD v2 query, and respiratory syncytial virus (RSV) defined using the CDC Respiratory Syncytial Virus v1 query.

<sup>5</sup> Reported using Centers for Disease Control and Prevention's (CDC) Influenza Sentinel Provider Surveillance System methodology. Currently one outpatient clinic at a college/university student health center reports for DuPage County.

<sup>6</sup> COVID-19-like-illness and/or infection (CLII) should include student and staff members who are absent due to 1) any of these [symptoms](#) that are not caused by another condition and/or 2) a positive COVID-19 viral test, with or without symptoms.
